Issue of JPY500,000,000 Fixed to FX Linked Interest Notes due 26 March 2043 under the €50,000,000,000 Debt Issuance Program (the 'Notes')

This document constitutes the Final Terms relating to the Issue of Notes described herein. Terms used herein shall be deemed to be defined as such for the purposes of the Conditions set forth in the Base Prospectus dated 10 May 2012 and the supplemental base prospectuses dated 14 September 2012 and 8 March 2013 which together constitute a base prospectus for the purposes of Directive 2003/71/EC (the 'Prospectus Directive' which term includes Directive 2010/73/EU (the '2010 PD Amending Directive') to the extent implemented in a relevant member state of the European Economic Area in which the Notes are issued (each, a 'Relevant Member State')). This document constitutes the Final Terms of the Notes described herein for the purposes of Article 5(4) of the Prospectus Directive and must be read in conjunction with such Base Prospectus as so supplemented. Full information on the Issuer and the offer of the Notes is only available on the basis of the combination of these Final Terms and the Base Prospectus as so supplemented. “FX_N” means the AUD/JPY foreign exchange bid-market spot rate expressed as a number of JPY per AUD determined by the Calculation Agent as the bid rate displayed on Reuters Screen “JPNU” page (or such other page as may replace such page on that service) as of 3:00 p.m. (Tokyo time) on ten (10) Sydney, TARGET, Tokyo and London business days prior to each Interest Payment Date (each such date an “FX_N Determination Date”).

“AUD” means Australian dollars.

For the avoidance of doubt, for purposes of determination of the FX_N Determination Date, the Interest Payment Date is subject to adjustment.

For information purpose only, the above formula is obtained by the development of the following formula:

$$\text{AUD } 10.00\% \times (\text{FX}_N / 79.50) - \text{JPY } 7.00\%$$

The Calculation Agent will request five leading reference banks (selected by the Calculation Agent at its sole discretion) in the Tokyo interbank market for their bid market quotations of the AUD/JPY spot exchange rate at approximately 3:00 p.m. Tokyo time on such date. The highest and the lowest of such quotations will be disregarded and the arithmetic mean of the remaining three quotations will be FX_N.

Provided that, if only four quotations are so provided, then FX_N shall be the arithmetic mean of such quotations without regard to the highest and lowest values quoted. If fewer than four quotations but at least two quotations can be obtained then FX_N shall be the arithmetic mean of the quotations actually obtained by the Calculation Agent.

If only one quotation is available, in that event, the

Calculation Agent may determine that such quotation shall be FX_N , and if no such quotation is available or if the Calculation Agent determines in its sole discretion that no suitable reference bank who is prepared to quote is available, the Calculation Agent will determine FX_N in its sole discretion.
